Tumkur District Armature Kabbaddi Association @ Tumkur is a Affiliated to Karnataka state Kabaddi Association, Karnataka committed to enhance the game of kabaddi and its publicity to especially rural students by way of Kabaddi skills, organization of kabaddi tournament and conducting coaching camp. Having recognized a mutual interest in enhancement of kabaddi game as well as facilitating towards their services both the parties agreed to enter into an MOU to facilitate and regulate such cooperation on the following terms and conditions.

General Terms of the Understandings.

This MOU shall become effective upon signature by both the parties and will remain in effect until modified or terminated by one of the parties by mutual consent.
