PURPOSE OF MOU

In particular, this MOU is intended to

- 2. Exchange of study materials, books and journals through book bank facilities of both the institutions.
- 3. Mutual co-operation for extension activities.
- 4. Considering a joint venture for add-on and certificate courses
- 5. Endeavor to encourage students and staff for a formal Exchange
- 6. conduct study tours, as mutually agreed in writing between the parties prior to commencement of this activity

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

1) Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations.

2) The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

3) The co-operation between the parties will facilitate effective utilization of the intellectual capabilities in teaching, research, extension activities



4) In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the program.

SCOPE OF THE MOU

1) Both parties believe that close co-operation between the two would be a major benefit both faculty and student community to enhance their knowledge and skills

2) The interaction between Industry and Community College Centre will give an insight into the latest developments /requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party.

3) Both the parties extend the necessary support on mutual interest and requirement to deliver guest / special lecturers on recent trends and in house requirements.

4) Both the parties will actively engage to help each other in internships and job trainings which help the placement of their students

VALIDITY

1) The validity of the agreement is for the period of Five years from the date of agreement.

2) Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
