## MEMORANDUM OF UNDERSTANDING

This memorandum of understanding (MOU) is executed at Tumakuru on 13/11/2023

Between

**NSS Units of Sree Siddaganga College of Arts, Science and Commerce for Women** incorporated under Sree Siddaganga Education Society® that has its registered office at Sree Shivakumar swamiji Road, Highway No. 33, Near Town Hall, Gandhi Nagar, Tumakuru – 572102. (Hereafter referred to as “Partner Institute”)

And

**Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru** that comes under Tumakuru Taluk and District.

Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru and partner institute shall individually be referred to as “Party” and collectively as “Parties”.

Partner Institute is a well-known institute in Karnataka, India. That offers different programmes to students. Here this institute is referred to as Party No.1

Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru is referred as party No.2

**Therefore, it is hereby agreed and declared by and between the parties as follows:**

The purpose of this MoU is regarding exploring the area of cooperation, benefiting both the parties.

### 1. Principal understanding

Pursuant to mutual discussion and understanding

- 1.1 Both the parties have agreed to extend community services that are carried out only in Tumkur District.
- 1.2 Sree Siddaganga College of Arts, Science and Commerce for Women have agreed to extend its Support in the community development activities.
- 1.3 The Students of the Institution shall have an access to participate in the Development activities.
- 1.4 Rotary Tumkur Prerana, Rotary International District 3192 supports the Institution and its students to develop Community skills.

1.5 Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru may hold Health checking camps, Dental checking camps, Blood donation camps, Personality Development Programmes, Cleanliness Drive, Awareness Programmes, Seminars, Workshops, field visits with the help and association of Sree Siddaganga College of Arts, Science and Commerce for Women, Tumakuru.

1.6 Party No.2 only provides all the financial support and party No.1 does not provide any financial assistance.

1.7 Both the parties have agreed to provide manpower for the programmes undertaken.

1.8 The Sree Siddaganga College of Arts, Science and Commerce for Women, Tumakuru may at the requisition of the Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru to preside over the said programmes as supra, amongst the dignitaries eligible to preside over the said programmes should nominate the said dignitaries for such programmes to be conducted by the Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru.

1.9 The Sree Siddaganga College of Arts, Science and Commerce for Women, Tumakuru shall depute the NSS unit volunteers along with NSS Programme Officers to the Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru for satisfactory conducting of the programmes as and when determined by the Rotary Tumkur Prerana, Rotary International District 3192, Tumakuru at the venue specified.

1.10 Nature of the programmes will be decided through mutual consideration.

## **2. TERM**

Unless terminated earlier, the term of this MOU shall be valid for a period of three year commencing from 13/11/2023 until further it is agreed between the parties that notwithstanding anything contained under this MOU. Either party can cancel or terminate this agreement unilaterally, by giving an adverse written notice of one month to the other. However, prior to the expiry of the term, the parties may mutually agree to renew this MOU.

## **3. REPRESENTATION AND WARRANTIES**

Each party to this MOU makes the following representation and warranties.

1. The person signing this MOU has the legal power and authority by virtue of statute/resolution, to sign this MOU for and on behalf of the parties and to perform and comply with its duties and obligations.

2. This MOU constitutes legal, valid and binding obligation enforceable against it in accordance with the terms hereof and represents that there is no contract, agreement or understanding with any person, partnership or any other entity/authority restricting or preventing it from performing its obligations/deliverables under this MOU.

#### **4. INDEMNITY**

Each party shall indemnify, save and hold fully harmless the other party from against any/all claims, losses, liabilities, actions, claims, suits, proceeding, (including any proceeding brought before any court, regulatory body, arbitration panel or other tribunal) damages, judgments arising out of or in any way connected with any branch of any representation, warranty and/or any terms under this MOU.

#### **5. CONFIDENTIALITY**

It is agreed that both the parties shall maintain confidentiality and mutual trust.

#### **6. FORCE MAJEURE**

Neither party shall be liable for delay in performance of its responsibilities/obligations hereunder which may be caused by an act which is beyond the reasonable control of either party. Should the Force Majeure Event subsist for a duration longer than 60 (sixty) days, the parties shall mutually agree the way forward including the right to terminate this MOU by serving a 90 (ninety) days prior written notices.

#### **7. GOVERNING LAW**

This MOU shall be governed by the applicable laws of India.

#### **8. NOTICES**

All notices or other communication to be provided under this MOU shall be in writing and may be communicated either through registered or e-mail.

#### **9. ENTIRE AGREEMENT**

No amendment or other variation of this MOU shall be effective unless it is in writing is dated and expressly refers to this MOU and is duly signed by the authorized representative of each party.






