





  - w) To do and cause to be done all lawful things and acts in accordance with the spirit of Constitution of India.
  - x) To develop potential of community sub groups such as Credit Management Groups (CMG) Self-Help Groups (SHG), Mahila Mandals (MM) Youth Association (YA) etc.,
  - y) To promote encourage and empower Men and Women Self-Help Groups (SHG) through the income Generation Activities like Small Savings Bank Linkage programs, Awareness camps, through the street play, Tele shows, cultural activities and then group discussion etc.,
  - z) To conduct awareness camps on social evil things, i.e., un-touchability, Basivini system and remaining social evil things.
  - aa) To involve in implementation of State, Central Government and world Bank assisted projects, programs like Jala Ssamruddhi Yojana Scheme (JSYS), Sujala Watershed development programs and Swashakthi projects etc.,
  - ab) To mobilize funds to achieve the objectives of the organization by accepting donation, grants etc., and by also conducting fund raising programs, from the country and abroad.
  - ac) To establish, maintain, develop and donate for the establishment, maintenance development of Eye Banks, Blood Banks and Drug Banks.
  - ad) To give sports training like Football, Volleyball, Kabaddi, Cricket, Badminton, Tennis, Snooker, Baseball, Golf, Billiards, carom, chess and skilled games etc.,
  - ae) To build Mini Stadium or Hall for Indoor Games, conduct competition and matches and start coaching classes for training youth in various sports.
  - af) The income of the society by whatever means shall be utilized for the objects of the society and shall not be distributed among its member or any body.

1. NAME OF THE ASSOCIATION : SSWC ALUMINI ASSOCIATION, JY
2. ADDRESS OF THE ASSOCIATION: Sri Siddaganga College of Arts, Science & Commerce for Women, B. H. Road, Tumkur.
3. MODE OF MEMBERSHIP

Admission of membership shall be only restricted to the old students who are previously studied in this Institution are eligible for membership and they are identified as Alumini groups. Those who are interested to join & work freely for the betterment of the Institution are submitting the application for membership to the Chairman or Secretary with their detailed informations.

The society shall consist of Two types of membership. The society is having the power either to accept or reject the application for membership. The decision of the committee shall be final.

1. Those who pay Rs. 5 00 /- shall be called as LIFE MEMBERS.
2. Those who pay Rs. 1 00 /- annually shall be called as ORDINARY MEMBERS.

The annual subscription shall be paid within the month of march of every year. If the subscription of a member shall not be paid after the march, their membership shall be ceased.

### 3. TERMINATION OF MEMBERSHIP

The termination of membership on Death, the member acting against the objects of the association, unsound mind, proved criminal action and other reasons as stated by the Executive Committee Members.

### 4. WORKING OF THE SOCIETY

Activities of the society shall be carried out through;

- a. General Body and
- b. Executive Committee

#### a. ANNUAL GENERAL BODY MEETING

1. General Body Meeting of the Society will be held annually within the month of June.
2. The president may call for a general body meeting for which 21 days early notice shall be given to all types of members.
3. A Special general body meeting shall be conveyed if necessary as per section 9 & 10 of the KSR Act 1960.

24 days clear notice to the annual general body meeting as well as 21 days notice to the special general body meeting shall be given and the subject matters to be discussed shall be stated in such notices.

Report of the Management of the existing working committee, audited statements and the Budget for the ensuing year shall be discussed and submitted for confirmation. Executive committee of the society shall be elected once in a years in the annual general body meeting.

In the event of any office bearer laying down office for whatever reasons the Managing Committee can co-opt any member consider suitable for the office for the remaining period or till elections are held.

8. Expel of a member may decide by managing committee in case any one member of the society is convicted of action in contravention to the Bylaws.
9. Any meeting of the society each member present shall one vote, except president who shall have one more vote. Voting may be by raising hands or secret ballots. In such meeting the postal ballot will also be taken into consideration before deciding the issue.

b. EXECUTIVE COMMITTEE

1. Executive Committee for the society shall be elected once in a years.
2. The executive committee shall generally meet once in one month for which the Secretary will give notice of seven days to the members.
3. To ensure funds and promote the primary aims & objects of the society.
4. To operate the funds and manage the property of the society to present the duly audited accounts of the annual general body meeting.
5. To publish the annual reports of the society.
6. Executive committee may invite to their meetings not less than two specialist/experts who may be non-members of the society with the deliberations if considered useful.
7. To appoint, retain, promote and dismiss any employees for managing and functioning of the society and to regulate their terms and conditions of employment including remuneration.
8. To administration and management of society shall vest in the executive committee consisting of **FOURTEEN** members including President, Vice President, Secretary, Treasurer and 03 committee Directors to be elected at the general body meeting once in a year of the society.
9. The remaining committee members may fill in any vacancy that may arise in the executive committee on consensus.
10. Any member of the executive committee being absent for three successive meetings without proper cause shall cease to member of the executive committee but eligible for re-elected.
11. The Executive Committee in its meeting shall consider all questions affecting business that may be interest to the members of the society and they shall inform and circulate any information which may be use and beneficial to the meeting.

5. QUORUM

The Quorum of the Executive, General and Special General Body Meeting shall be 2/3rd of the members present and voting.

6. RESPONSIBILITIES & POWERS OF THE OFFICE BEARERS

A) PRESIDENT

He/she shall be overall in charge of the society and general body meeting. All the policies and programs shall be formulated and implemented only through him.

He/she in case of emergency if He/she thinks fit may also dissolve the council or promoters provided however, that the council of promoters appointed by the Chairman under this sub rule shall function only until the new council of promoters is elected at the next annual general meeting immediately falling the appointment of such and hock council of promoters.

He/she shall guide and supervise the various activities of the society. He/she shall

**D) TREASURER :**

**7. FUNDS OF ASSOCIATION :**

1. Contributions received from Rich Donors, NRI (Non residence of Indians) out of the primary citizens patron members, and Life members, Well-Wishers, Philanthropists and the Primary member's subscriptions.
2. The property that are obtained in the form of charities and from the Donors
3. Financial assistance from the State and Central Government and Abroad.
4. The funds of the society shall be invested in the modes specified under the provisions of Sec. 13(a) (d) R/w Sec. 11(5) of the Income tax 1961 as amended from time to time

5. These shall be maintained all account of the society regularly. A CHARTERED ACCOUNTS shall duly audit the accounts every year the accounts shall be closed by 31<sup>st</sup> March.

6. No amendments to the Bylaws/Rules and Regulations shall be made which may prove to be repugnant to the provisions of section 2(15) 11, 12, 13, 12A, 80G, 80G5 & 6, 35AC I & II, 10, 23C or such other sections of the income Tax Act 1961 as amended from time to time so that the income of the society will be exempt from Income Tax.
7. In the event of dissolution or winding up of the society, the Assets remaining as on the date of dissolution shall under no circumstance be distributed among the members of the managing committee but the same shall be transferred to another charitable Society whose objects are similar to those of this society and which enjoys recognitions under section 80G of the income Tax 1961 as amended from time to time.
8. Every member of the society shall be bound by the provisions of the memorandum of Association of the society and these Rules and Regulations, By-laws and Decision from time to time made or taken by the Society in General Meetings or Governing Body Meetings.
9. In the event of any vacancy arising among the ordinary members of the Governing Body by resignation, leaving the society, expulsion from the Society or death, such vacancy shall be filled by the Governing Body members of the family.
10. To acquire movable and immovable property of any tenure throughout India by way of purchase absolutely or by way of lease, exchange, gift of any other form of acquisition at such rates, terms and conditions as the Governing Body may agree to.
11. The benefits of the society shall be open to all irrespective of Caste, Creed, Religion or Country.
12. The funds and the income of the society shall be solely utilized for payment to the members by way of profit, interest, dividends etc.,
13. Objects/Activities of religious nature require deletion.
14. To ensure that all monetary transactions are through Nationalized Banks/Co-operative Banks.

**8. ACCOUNTS OF THE SOCIETY:**

1. Official year of the society shall be 1st April to 31st March of every year.
2. The Assets & Liabilities and Income & Expenditure shall be laid before the annual general body meeting for confirmation.
3. Such balance sheet and income & Expenditure and the list of Executive Committee members shall be filed with Registrar of Societies as per section 13 of the KSR Act 1960.

**9. GENERAL:**

1. Alterations and Amendments to the Memorandum of Association shall be made as per section 9 of the KSR Act 1960.
2. Change of Name, Address, Rules and Regulations shall be made as per section 10 of the KSR Act 1960 shall be followed.
3. Regarding Amalgamation of the Society if it arises, section 21 of the KSR Act 1960 shall be followed.
4. The dissolution of the society if it arises, 22 and 23 of the KSR Act 1960 shall be followed.
5. The things and matters and which have been specifically provided for therein above the provisions of the KSR Act 1960 and rules made there under shall be applies.



Preside over the council of promoters and at the annual general and other general meeting. The ruling of the Honorable chairman at the council of promoters /managing committee shall be final and binding on all the questions raised.

**B) VICE-PRESIDENT NO. 1,2 AND 3:**

**C) SECRETARY :**

1. He/she shall call for all the meeting of the governing body as and when deemed necessary and the general and the special general body as per the rules with the previous approval of the president and maintain a minute books and record all the proceedings of the meeting.
2. He/she shall be the removed from the office if he proved to be misconduct of any irregularities of misappropriation or inefficiency in discharging the duties of the society by the unanimous decision of the governing council duly endorsed by the general body in an emergency meeting call for the purpose and 75% of the total votes cast in such meeting
3. He /she shall be the custodian of all articles and belonging both movable and immovable of the society
4. The Secretary shall keep all accounts and ledgers of the association and produce them before the managing committee and to co-operate with the auditors in preparing financial statements etc.,
5. He/she all be the correspondent of the society and shall be in charge of the office with all the records of the society
6. To keep or cause to be kept in proper order and custody of all documents and all paper and file belonging to the society
7. He/she shall have the powers obtain movable and immovable properties of the society in legal way
8. However the President and Secretary shall operate the Bank accounts jointly.
