





There shall be a maximum of Eleven trustees on the Board. The board has the power to appoint sub-committees, special committees etc. The Board will decide the power and term of such sub-committees.

Managing Committee shall work towards achievements of objects of the trust under the general supervision and delegated powers of the Board of Trustees.

Terms of the trustees:

- 01. Term of the trustees Till they attain the age of 70 years.
- 02. Appointment of new trustees The board of trustees shall have the power to appoint new trustees as and when the vacancy arises.

# 8. POWERS OF THE MANAGING COMMITTEE.

In execution of this trust and with a view to carry out the objects of this trust and to augment its funds and to administer them in discharge of their duties, the Managing Committee shall have the following powers.

- a. To carry on the objects of the trust as stated in clause (4) of the deed.
- b. To receive any money or other assets in any shape or form and when given by the "Author of the Trust" or any other person/s, Trust, Government Agencies, Institutions, Society, etc., as gift or donation.
- c. To collect funds by donations, grants, presents or contributions and other offerings from within the country / outside the country with requisite authorities.
- d. To invest the Trust Funds in such securities and in such manners as may be prescribed under the provisions of Section 13(1) r.w.s 11(5) of the Income Tax Act, 1961 for the time being in force and as amended from time to time.


#### 11. DUTIES OF SECRETARY

The Alumni Association (R.), which has been built by all the senior students, is working hard for the prosperity of the college in several ways.

## Nithya Dasoha-Mid-day Meal:

The Alumni Association meets every year on 26th January in the college. The Alumni Association has devised a unique program to benefit today's students of our college. It has taken up the service of providing free mid-day meal in the college to 100 deserving students coming and going from villages around the city. Students coming from places like Aammasandra, Nitturu, Turuvekere, Chikkanayakanahalli, Gubbi, Dabaspete, Madhugiri, Nelamangala have to leave home very early in the morning. For these students who have to catch a train or bus early, breakfast cannot be made at home. Such students also find it difficult to bring lunch. After the college session is over, these students reach home at 6:00 pm. Although there is a canteen facility in the college, many students do not have the capacity to pay money to have meals every day. Realising this situation, the Alumni Association has already started the Nithya Dasoha

program in Sree Siddhaganga Women's Degree College. At Rs. 35 per meal, it costs Rs. 3500 to feed 100 students daily. Some members of the Alumni Association and faculty of the college have generously contributed funds for the Nithya Dasoha.
