## Scope of Cooperation:

- BOAT (SR) and the Institution will work together to identify suitable apprenticeship opportunities for students.
- The Institution will integrate apprenticeship and internship programs into their curriculum as per regulatory body guidelines.
- Both parties will promote active linkage between the higher education system and industry, non-commercial, and commercial enterprises/organizations.
- BOAT officers implementing apprenticeship in the respective states will serve as a liaison between BOAT (SR), the Institution, and establishments to ensure smooth coordination and implementation of the programs.
- Institution shall have linkage with establishments to impart apprenticeship training and ensure that these establishments shall be enrolled into the NATS Portal with coordination of BOAT-SR.

## Operational Aspect:

- The institution is solely responsible to seek approval from respective authorities for embedding industrial training component for apprenticeship training.
- The stipend component shall be taken care of by the respective establishment and BOAT-SR as per the Apprentices Act, 1961.
- Monitoring of apprentice performance shall be conducted by establishments in coordination with HEIs
- Apprenticeship credits/marks/final certification shall be the sole responsibility of the institution

## Salient features of Apprenticeship Embedded degree Program:

### Admission Details:

- The students in the Final year having an Industrial training component can be covered under NATS on a stipendiary/non stipendiary basis.

### On the Job Training (OJT) details:

- The students of each batch would be imparted 06 months to 01 Year Apprenticeship Trainee programme in industrial/commercial establishments in line with the Apprentice Act, 1961.

### Curriculum, Assessment & Certification:

- The suitable course curriculum could be designed by The Principal, Sree Siddaganga College of Arts, Science and Commerce for Women, B. H. Road, Tumkur according to the UGC/AICTE/Any government regulatory body's guidelines, containing an Industrial training component.
- The assessment and evaluation of Apprenticeship training would be carried out jointly by The Principal, Sree Siddaganga College of Arts, Science and Commerce for Women, B. H. Road, Tumkur and Industry. Board of Apprenticeship Training (SR), Chennai would oversee the overall training imparted in the establishment.
- After successful completion of on-the-job training, a Certificate of Assessment would be issued jointly by The Principal, Sree Siddaganga College of Arts, Science and Commerce for Women, B. H. Road, Tumkur and Board of Apprenticeship Training (SR), Chennai / Industry/ Commercial Establishment imparting training.
- The degree certificate would be awarded by The Principal, Sree Siddaganga College of Arts, Science and Commerce for Women, B. H. Road, Tumkur after successful completion of the programme.

- Either party can terminate the MoU after serving three (3) months' notice in writing if there is a failure


## Force Majeure:
